Enter these numbers into the appropriate lines on the first page to find the Total Permit Fees.

**This is a fee estimate only. Actual fees will be determined when plans are received and reviewed.**

## **EXAMPLE**

### **Calculating a Permit Fee**

First calculate the project valuation:

- 1<sup>st</sup> Step: Total sq. ft. of finished area - 1200  
 2<sup>nd</sup> Step: Multiply 1<sup>st</sup> step by - \$56.46 x 1200 = \$67,752  
 3<sup>rd</sup> Step: Round up to the next thousand - **Total valuation = \$68,000.00**

The total valuation falls in the \$50,000.01 to \$100,000 range from the table on the previous page, so the fee is calculated like this:

$$\begin{aligned}
 &\text{First \$50,000 of your valuation} = \$994 \\
 &\quad + \\
 &\text{\$10.81 for each additional \$1,000 } (\$68,000 - \$50,000 = 18,000) \\
 &\quad \text{So multiply \$10.81 by 18 additional thousands} = \$194.58
 \end{aligned}$$

$$\text{Your permit fee is } \$994 + \$194.58 = \text{\$1,188.58}$$

★ **Please be aware:** this is for a basement finish or remodel only. Basement finishes for an Internal Accessory Dwelling Unit (rental unit) must go through the I-ADU process which has different fees and requirements (see our webpage at [Accessory Dwelling Units - Internal](#) for the correct fee calculator).
